### **STATEMENT OF FIRE DEPARTMENT DUES:**

Dues for the period of July 1, 2026 through June 30, 2027, in the amount of \$60.00 for the first property and \$30.00 for each additional property – residential/business, are due.

You have several ways to choose from for paying your fire dues.

You can fill out the following page and mail with your payment to the address listed above. This portion of the dues letter and your canceled check shall constitute your receipt for dues paid for insurance purposes.

You can come to the Stoutland Fire Station on the first or third Saturday of each month between 9 am and noon to pay in person.

You can remit payment at the City of Stoutland City Hall on Tuesdays and Thursdays between 8 am to noon. Checks and money orders must still be made out to Stoutland Volunteer Fire Department.

You can also pay your dues online via the link on: <https://ssvfds.org/annual-dues/> If you choose to pay online, there is an additional surcharge of \$5 per every \$60 in your payment to cover fees to use online bill pay.
